### **OFFICE ORDER NO: 10 OF 2025**

Competent Authority, on the recommendation of the Departmental Promotion Committee, has ordered in-situ promotion of following official from the cadre of Optometrist to the cadre of Senior Optometrist, in the Pay Matrix Level 6, as per CCS (RP) Rules, 2016 (PB-II Rs. 9300-34800/- + GP Rs. 4200/-), on regular basis:

1. The regular Promotion of the above official will take effect from the date on which she assumes the charge of promotional post at her ordered place of posting.
2. The above official shall exercise the option for fixation of pay, either from the date of promotion or from the date of next increment, within one month from the date of their promotion, as per the clause under FR 22(I)(a)(1) provided that option for fixation of pay in the promotional cadre in the above manner under MACP Scheme has not been availed/exercised earlier. **The option, once exercised, will be final.**
3. The declaration regarding the acceptance/refusal of the promotion offered should be communicated by the official concerned by **11.06.2025** through the respective Controlling Authority. **In the absence of any communication, it will be presumed that she has not accepted the promotion and no correspondence in future will be entertained in this regard.**
4. The promotion is subject to the terms and conditions of service as applicable to the similar class of employees as laid down in the ESI Corporation (Staff and Conditions of Service Regulations, 2023, as amended from time to time.
5. The promotion of the official ordered against the reserved category, if any, will be subject to satisfactory verification of their Caste Certificate from the Competent Authority concerned. **Such official has to submit their latest Caste Certificate to this office through their respective Controlling Authority within one month of issuance of this order.**
6. The Seniority of the promoted official will be determined in accordance with the order of the recommendation of the DPC.
7. Those who decline the offer of promotion will not be considered for regular promotion for a period of one year and will also be superseded, resulting in loss of seniority, as per rules, and the other officials promoted on regular basis prior to the date of their next promotion to the promotional post will become seniors to them.
8. Promotion of the official shall be subject to the final outcome of the SLP(C) No. 30621 of 2011 pending before Hon'ble Supreme Court.
9. Joining Report of the concerned official may be sent to this office in due course.
