REGULATIONS:

The following are the Regulations for admission into Post Graduate Medical Degree / Diploma Courses under Competent Authority Quota for the academic year 2025-26 and shall apply for admissions into all the Medical Colleges affiliated to KNR University of Health Sciences in the State of Telangana.

1. NUMBER OF SEATS UNDER COMPETENT AUTHORITY QUOTA

- a. The number of seats to be available for the academic year 2025-26 in Post Graduate Medical Degree/Diploma courses after excluding seats contributed to All India Quota from Government Medical Colleges and Competent Authority Quota seats in Private Medical colleges will be in accordance with the orders of the NMC / GOI / Govt. of Telangana.

The seat matrix for Competent Authority Quota seats for academic year i.e., 2025-26 shall be displayed in the KNRUHS website before notification for exercising web options for counseling.

- b. In case any new PG Medical seats are permitted by Government of India in colleges affiliated to the KNRUHS for the Academic Year 2025-26, those seats also shall be filled up. No further notification shall be issued.

2. ELIGIBILITY

The candidates who fulfill the following criteria are eligible for admission into Post Graduate Medical Degree and Diploma courses. Candidates have to apply online and upload the original certificates for Competent Authority Quota seats in colleges affiliated to Kaloji Narayana Rao University of Health Sciences, Warangal.

A. ELIGIBILITY AS LOCAL CANDIDATE:

(as per G.O. Ms. No. 148 HM&FW(C1) Dept., dated 28-10-2024)

- i. A Candidate to be eligible for Admission into PG Medical Courses under these Rules should be an Indian National/Person of Indian Origin/Overseas Citizen of India card holder and be a local candidate.
- ii. Local candidate means a candidate who has studied in the Educational Institutions in the state of Telangana for a period of not less than four consecutive years ending with the academic year in which he appeared or as the case may be, first appeared in the relevant qualifying examination subject to

Explanation (a): A candidate who is regarded as a local candidate for the purpose of Admission into Undergraduate (MBBS) in the state of Telangana, but has studied in a State wide Institution outside the state of Telangana, shall also be regarded as a Local candidate.

Explanation (b): A candidate, who has secured Admission to the relevant Undergraduate course (MBBS) under Non-Local Quota in the State of Telangana, shall not be regarded as Local candidate.

- B.** Candidate should have qualified in NEET-PG-2025 by securing marks of Cut-off score or above as displayed above.
- C.** Candidate should have passed MBBS/ Equivalent Degree examination from a Medical Institution in Telangana State/ Siddartha Medical College, Vijayawada (State wide institution) recognized by the National Medical Commission.
- D.** Candidates who hold recognized Medical Degree should have obtained Permanent Registration from Telangana State Medical Council after completing compulsory rotating internship.
- E.** MBBS Graduates should have completed internship on or before **31-07-2025**.
from recognized Medical Colleges (by NMC).
- F.** In case of In-service candidates, Government service rendered shall be calculated as on **31-08-2025**.
- G.** Candidates from other states are not eligible for Competent Authority Quota seats.

- H. Candidates who are studying Postgraduate Degree/Diploma and DNB courses are not eligible to apply for Postgraduate Degree/Diploma courses.
- I. The candidates qualified in NEET-PG-2025 examination with the following cutoff scores and above as per Notice of National Board of Examinations, New Delhi are eligible to apply.

Category	Minimum eligibility criteria	Cutoff Score
General/EWS	50 th percentile	276
General PWD	45 th percentile	255
SC/ST/OBC (Including PWD of SC/ST/OBC)	40 th percentile	235

Note: If a candidate is found to have submitted false information or concealed any relevant information regarding this matter, such candidate is liable to be disqualified for admission and in case already admitted, the admission shall be cancelled. Further disciplinary action against him/her shall be initiated by the University as per rules.

3. The rules for admission into Post Graduate Medical Degree and Diploma courses under Competent Authority Quota have been issued by Government vide G.O.Ms. No. 155, HM&FW (C1) Department Dated: 18-11-2021, G.O.Ms.No.73 HM&FW(C1) Department, Dated:03-07-2023, G.O.Ms.No.148 HM&FW(C1) Department, Dated:28- 10-2024 , and G.O. Ms. No. 10, SCD(POA.A2) Dept., Dated: 14.04.2025 for SC bifurcation and other relevant Government orders and subsequent amendments. These rules are strictly applicable for admission procedure (eligibility criteria, seat matrix, reservations, selection procedure etc.). Relevant Hon'ble Supreme Court & Hon'ble High Court of Telangana orders shall also be followed.
4. **RESERVATIONS**
- 4.1 15%, 10%, 29% seats of Post Graduate Degree and Diploma Courses are reserved for SC (SC-1%, SC2- 9%, SC3-5%), ST-10% and BC (BC-A-7%, BC-B-10%, BC-C-1%, BC-D-7% and BC-E-4%) categories respectively.

- 4.2 Candidates claiming reservations under SC/ST/BC categories shall upload latest social status certificate issued by the Competent Authority of Government of Telangana as specified in the application form. Candidates claiming reservations under SC/ST/BC categories shall be eligible only for the castes included under the approved list of SC/ST/BC categories notified by the Government of Telangana.
- 4.3 Minority Medical Colleges seats are reserved for Muslim Minority category candidates only.
- 4.4 33 1/3 % of seats shall be reserved for women and 5% seats shall be reserved for Persons with Disabilities (PWD) candidates respectively, which are horizontal reservations for the Post Graduate Degree and Diploma Courses.

Note: The regulations of Medical Council of India/NMC shall be implemented in admissions of the candidates under Persons with Disability (PWD) category.

The candidate seeking admission under PWD reservation should apply under PWD Category.

The Medical Board constituted by the University as per the Government Orders issued as Rules for admission into Post Graduate courses. The Medical Board shall assess the percentage of disability as per Medical Council of India/NMC regulations. Candidates claiming reservation under PWD quota should present themselves before the Board constituted by the University for evaluation of PWD percentage and confirmation of eligibility. The decision of Medical Board specially constituted for this purpose is final and binding on the candidates. The schedule for evaluation by the Medical Board shall be displayed on KNRUHS website.

4.5 **IN-SERVICE QUOTA RESERVATION:**

20% of seats in Postgraduate clinical broad specialties and 30% of the seats in Postgraduate Pre and Para clinical broad specialties for Degree and Diploma courses are reserved for in-service candidates under Service Quota which are horizontal reservations. Eligibility criteria for In-service candidates are as notified in G.O.Ms.No.155, HM&FW, Dated: 18-11-2021.

4.6 ELIGIBILITY FOR STUDY LEAVE

Eligibility for Study leave shall be as notified in G.O. Ms. No.155, HM&FW (C1) Dept., Govt. of Telangana, Dated: 18-11-2021.

5. ONLINE APPLICATIONS

5.1 The on-line application form for determining merit position in respective categories for Competent Authority Quota seats using NEET- PG -2025 rank shall be available on the website <https://tspgmed.tsche.in> from **08.00 AM on 01-10-2025 up to 05.00 PM on 08-10-2025 only.**

5.2 Registration and processing Fee for PG Degree/Diploma courses:

The Registration and processing fee of Rs.10,000/- (Bank transaction charges extra) is for OC & BC candidates and Rs.8000/- (Bank transaction charges extra) for SC/ST candidates. The fee shall be paid online through Debit card / Credit card or Net Banking. **

** Registration and processing fee once paid shall not be refunded or adjusted to a further date.

5.3 Therefore, candidates are advised to check eligibility criteria thoroughly before applying for determining merit position in respective categories for State quota seats as per NEET PG – 2025 scores

Note: The candidates are advised to take a print out of the Prospectus / Instructions to fill the application form from the website <http://knruhs.telangana.gov.in> or <https://tspgmed.tsche.in> before proceeding to fill the application form.

5.4 The candidate should fill the online application form available in the website with the data required through any computer with internet connection. The candidate is advised to fill the online application form after going through the Prospectus and by keeping all the Certificates, Scanned Photo and Signature in the jpg/.gif format separately (as shown below) (step-1) ready. Candidates shall enter his/her correct data and upload the photo, signature and original certificates after the payment of registration and verification fee through Online.

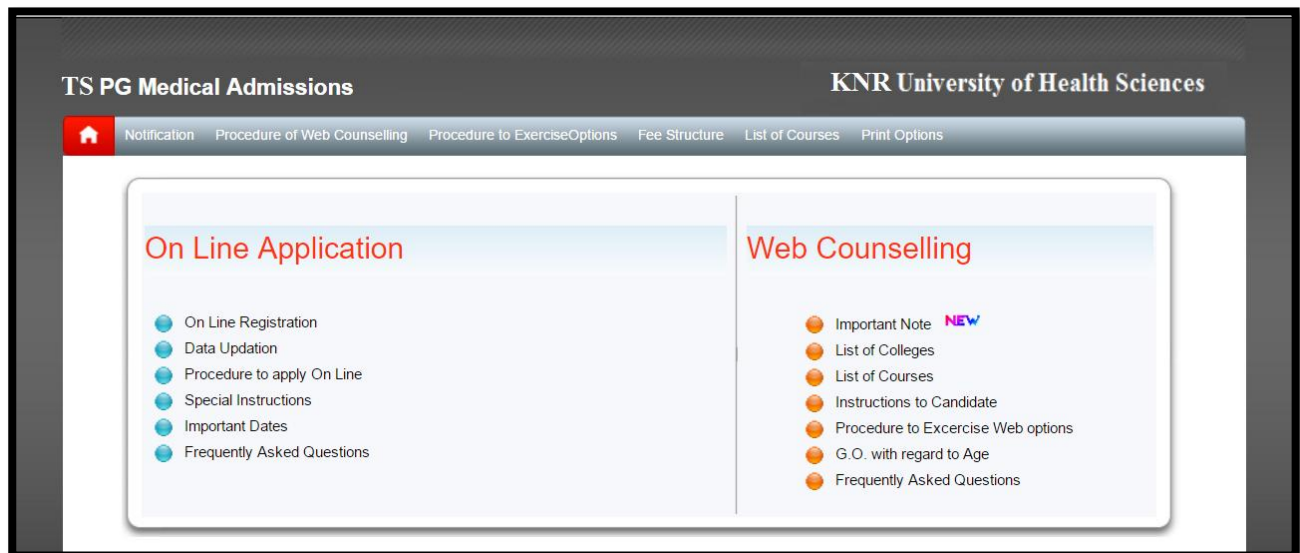
1. Open the website <https://tspgmed.tsche.in> Home page displayed as follows.

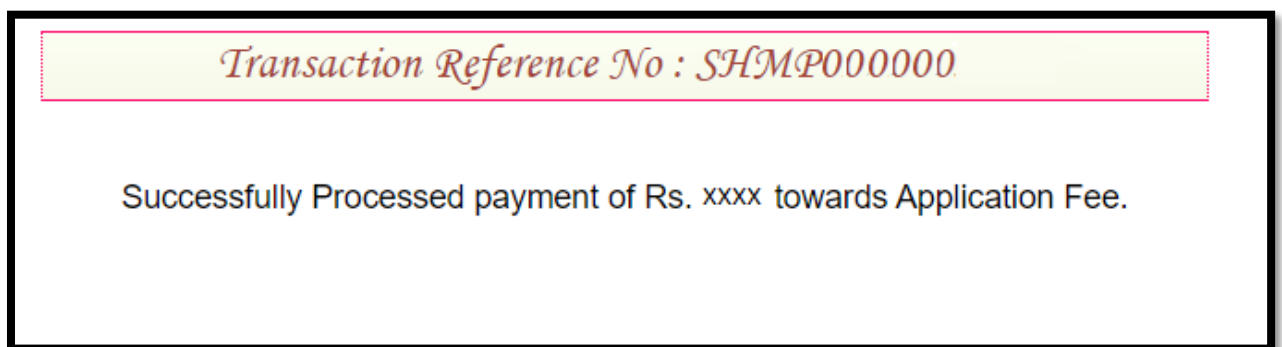
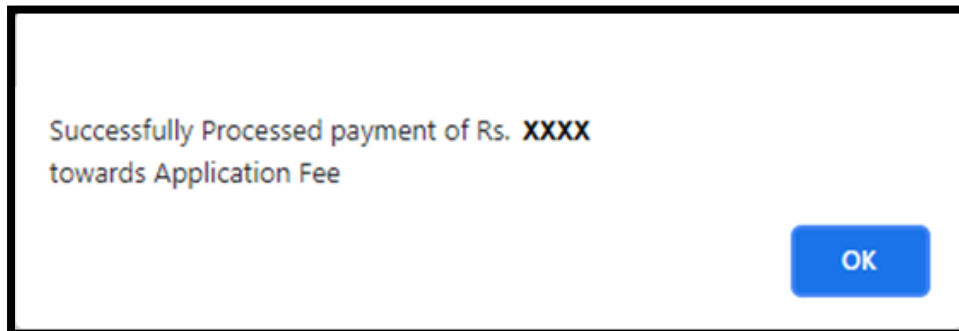



IMPORTANT NOTES

1. Registered Medical Practitioners should be careful to send the registrar immediate notice of any changes in their registered addresses.
2. They should also answer all inquiries that may be sent to them by the Registrar in regard thereto, in order, that their correct addresses may be duly inserted in the Medical Register.
3. No charge is made for alteration of addresses. Once in five years the Registered Medical Practitioners must intimate his / her addresses to the Registrar for keeping the register alive.
4. A copy of the annual medical register where in the name appears will be supplied to every person registered on payment.
5. After the publication of name in the printed medical register the last edition of the register alone is the legal evidence of registration.
6. All persons registered under this act are eligible to practice modern system of Medicine.

6. DETERMINATION OF PROVISIONAL AND FINAL MERIT LIST:

- a. The provisional and final merit position of the candidates who have applied online in response to the notification issued by KNR University of Health Sciences for Competent Authority Quota seats shall be determined by NEET-PG-2025 rank and as per their eligibility criteria, applicable regulations, guidelines and reservation policies viz:
- b. As per PG Medical Regulations of National Medical Commission, the candidates shall secure minimum of 50 Percentile for General category, 40 Percentile for SC/ST/BC category and 45 Percentile for Persons with Disabilities (under general category) in NEET-PG-2025 as per the Cutoff scores to be eligible for admission.
- c. The University shall release provisional and final merit list of eligible candidates for exercising web options after verification of uploaded original certificates by the University and officials of the concerned departments.

NOTE: Candidates who have applied online in response to this office notification for determining merit position for Competent Authority Quota seats shall upload the original certificates online along with the application. Candidates have to submit one set of print out of application form, original certificates and one set of self-attested copies of certificates at allotted college at the time of admission for final verification. In case of any discrepancy, allotment of admission is cancelled automatically.

7. COUNSELING

Provisional and Final merit list shall be displayed on KNRUHS website after scrutiny of uploaded certificates and application. Verification of uploaded certificates shall be done only once for web-based counseling irrespective of number of phases of exercising web-based options and counseling. Hence, candidates who have applied through on-line are advised to upload all original certificates at the time of online registration without fail for scrutiny by the concerned departmental officials. No individual communications shall be sent. The notification for schedule for exercising web options shall be issued separately on KNRUHS website. Candidates are informed to check the website regularly for notifications.

The Admission Committee shall have power to review the selection in case of any errors, misrepresentation or glaring injustice and cancel the selection/admission. In all matters relating to selection and admissions, the decision of the Admission Committee shall be final and binding on the candidates and selections cannot be questioned after admissions are closed.

The procedure of selection of candidates shall be as per G.O.MS. NO.155, HM&FW (C1) DEPT., Govt. of Telangana, Dated: 18-11-2021, G.O.Ms.No.73, HM&FW (C1) Department, Dated: 03-07-2023, G.O.Ms.No.148, HM&FW (C1) Department, Dated: 28-10-2024 and G.O. Ms. No. 10, SCD(POA.A2) Dept., Dated: 14.04.2025 for SC bifurcation, relevant Government orders, subsequent amendments from time to time and relevant Hon'ble Supreme Court of India and Hon'ble High Court of Telangana orders.

The Tuition fee for Competent Authority Quota seats in respect of Degree and Diploma of clinical, para- clinical and pre-clinical courses shall be as notified by the Government of Telangana.

8. ADMISSION RULES:

- i. The letter of allotment for admission of selected candidate has to be downloaded from website after payment of University fee by payment gateway.
- ii. All the candidates including In-service candidates joining into the Post Graduate degree, diploma courses shall execute bond on a non-judicial stamp paper of Rs. 100/- as prescribed in Annexure-II to the effect that he / she shall complete the prescribed period of training or in default to pay **Rs.50,00,000/- (Rupees Fifty Lakhs only)** to the KNRUHS and shall refund the amount received as stipend/salary upto that date to the Government.

iii. Bond for service after completion of degree:

All Postgraduates (excluding in-service candidates) shall serve the Government of Telangana, if necessary, in Government institutions for a period of one year as per the orders of the Telangana State Government. A bond of Rs.10,00,000 (Rupees ten lakhs only) on admission into Postgraduate Diploma course and Rs.20,00,000 (Rupees twenty lakhs only) on admission into Postgraduate Degree course shall be executed by candidates at the time of admission.

iv. The admitted candidates who discontinue the course after the last date for Free Exit shall have to pay penalty of **Rs.50,00,000/- (Rupees Fifty Lakhs only)** to prevent seat blocking. They shall be debarred from participating in counselings for admission into Post Graduate Degree, Diploma courses for a period of three (3) years under KNR UHS.

v. The original certificates submitted by the candidates at the time of admission to the Principal of the allotted college shall not be returned to the candidates until they complete their course of study, subject to sub-regulation 8,(ii) and 8,(iii) above.

vi. **Attendance:**

Candidates selected for the various courses should be whole time resident students. Candidates have to compulsorily stay in hostels, wherever provided by college management. In service candidates shall have to apply for study leave to pursue their studies and are required to produce the leave sanction order from the Competent Authority not later than three months after joining the course. The candidate is required to put in a minimum of 80% attendance for being eligible to appear for the University examination.

a) For Three Years Degree course: -As per NMC regulations total days in a three year course will be 1095 days. So the total working days will be 939 days after deducting weekly offs (52×3 years =156 days). A student will require 80% attendance of working days (i.e., 751 days of 939 days) for appearing to University Examination. However, period of training will be extended by the same number of days for which maternity/ paternity leave and total excess casual leave have been availed in three years.

b) For Two- Years Diploma course:- As per NMC regulations total days in a two year course will be 730 days. So the total working days will be 626 days after deducting weekly offs (52×2 years =104 days). A student will require 80% attendance of working days (i.e., 501 days of 730 days) for appearing to University Examination. However, period of training will be extended by the same number of days for which maternity/ paternity leave and total excess casual leave have been availed in two years.

10.6 **Leave:** Students will be permitted to avail 20 days leave per year. 5 days of academic leave is permitted for entire duration of the training period. Post Graduates are not allowed to go on leave for more than 10 days continuously.

In-case of Medical Leave / Maternity Leave / Any other Leave or unauthorized absence beyond 20 days in a year, the study period of the candidate will be extended to the extent of such period. No other leave is permitted.

vii. **Maternity Leave:** Women students can avail Maternity leave upto 180 days only once in their PG course of study and the study period shall be extended to the extent of Maternity leave availed. The candidate shall not be eligible to appear for the University examinations till the completion of study period as per NMC Regulations (Duration of course).

viii. **Sanction of leave beyond (3) months and termination of studentship:**

- a. Every candidate after his admission shall attend classes on all working days (Theory, Practicals, Clinicals). If a student absents continuously for a period of (91) days or more and seeks permission to attend the course before 2 years after discontinuation, the candidate's application in the prescribed proforma shall be forwarded to the Registrar KNRUHS with the recommendations of the Principal with requisite fees. If the Vice Chancellor is satisfied with the reasons for absence, the candidate may be granted leave of absence and be permitted for Re-admission attaching such conditions as deemed necessary. Candidates who are absent for a continuous period of more than 2 years shall be deemed to have forfeited the admission into the course and the studentship shall stand cancelled without any further notice.
- b. If the break of study (91 days or more) is in more than one spell, the candidate's application in the prescribed proforma shall be forwarded to the Government of Telangana for appropriate decision in the matter with the specific recommendations of the Executive Council of the university.
- c. Candidates, who are absent for cumulative period of more than (2) years, shall be deemed to have forfeited the admission into the course and the studentship stands cancelled without any further notice.
- d. The candidate has to pass the final examination for award of Degree for the course within double the duration of study period for the course or within the maximum period permitted by the National Medical Commission from time to time.
- e. On Re-admission the study period for the course shall be extended equivalent to the period of absence and the candidate shall be eligible to appear for final examination after completion of the extended study period for the course".

ix. **Private Practice:** Post Graduates are not allowed to do any private practice or consultation and should not accept any part time employment in any State or Central or Quasi Government or Private organizations during the period of Post Graduation study. The Principal has to take appropriate action after giving opportunity for explanation, if any student violates this rule.

9. **COLLEGE REGULATIONS:**

Candidates are required to follow the rules and regulations of the college and should also abide by the regulations of the University. Candidates are informed that their correspondence with the University shall be forwarded by the Principal of the college with his remark. (through proper channel) for consideration. Under no circumstances they should have any correspondence with higher authorities directly without prior permission of the Principal.

10. **CLOSURE OF ADMISSIONS:**

- i. The admissions shall be closed as per the schedule notified by the University as per NMC Regulations.
- ii. Any vacancy after the date of closure of admissions shall not be filled. They shall not be carried forward to the next year as per the directions of Hon'ble Supreme Court of India.

11. **COMMENCEMENT OF THE COURSE:**

The course shall commence as per the schedule notified by the National Medical Commission. The duration of the course shall be calculated from the date of commencement of the course and shall be uniform for all the candidates irrespective of individual dates of admission.

12. **DURATION OF COURSE:**

- i. The duration of P.G. Diploma courses is 2 years and P.G. Degree courses is 3 years, In the case of students having a recognized two year Post Graduate Diploma course in the same subject, the duration of Degree course in the same subject shall be two years.

ii. **DISSERTATION:**

The Post Graduates must register the topic of their dissertation with the University after admission within six months of commencement of the course and approval of the University should be obtained. The dissertation shall be submitted within 2 ½ years of commencement of the course. In case of the candidates granted

exemption of one year of study period of degree course (candidates passed diploma of the same subject), the dissertation shall be submitted within 1½ years of commencement of the course. If the above schedule is not followed, the period of Post Graduation course shall be extended by six months.

- iii. A student of a Postgraduate degree course in broad specialties shall present one poster and present one paper at a National / State conference. Candidate has to present one research paper which should be published / accepted for publication /submitted for publication during the period of his / her Postgraduate studies so as to make him / her eligible to appear at the Postgraduate degree examination.
- iv. A Candidate registered for MD/MS Degree Examinations shall pass the final examinations within 4 years after completion of the course and the candidates registered for P.G. Diploma courses should clear the examination within 2 (two) years after completion of the course. If he / she does not pass the examination within the period specified above, he / she shall not be permitted to appear for University examinations thereafter.

13. MIGRATION AND TRANSFER OF CANDIDATES:

Migration / Transfer / Mutual transfer of Post Graduate students from one Medical college to another Medical College, from one course to another course and from Degree to Diploma and vice versa shall not be permitted under any circumstances.

14. POWERS OF PRINCIPALS:

Not with standing anything contained in these regulations, the Principals of Medical Colleges in the State may at any time before completion of the Post Graduate course either on his own motion or on the application of any person after due and proper enquiry and after giving the person two weeks time from the date of the receipt of the show cause notice to submit a written explanation and or on a personal hearing, order the cancellation of admission to the course, if in his opinion, such candidate had furnished incorrect particulars or false information in the application form or in the documents attached thereto or in the Statements made either before the authority In-charge of admissions or the Principal or any other manner. Against any such order of the Principal, an appeal shall lie to the Registrar, KNR University of Health Sciences, Telangana.

15. POWERS OF THE KNR UNIVERSITY OF HEALTH SCIENCES:

KNR University of Health Sciences, may either suo moto or on an application made to them, call for and examine the records relating to any selection or admission or cancellation thereof in respect of the admission made by the concerned Authority, for the purpose of satisfying themselves as to the correctness of legality or propriety of such selection or cancellation and pass such order in relation there to as they deem fit including cancellation of the selection already published or admission already made, provided that the University may, before canceling such selection or admission, give an opportunity to the authority and to the person affected to show cause against such cancellation. University has every right to cancel the admission of any candidate without any notice, if the certificates produced by the candidate are found to be fake / false/forged.

16. DISCIPLINE:

The students shall maintain strict discipline during the period of study/training program. The candidates shall not resort to any strikes during the period of their study. The students are not permitted in criticizing the policies of the Institute/University either before the print or electronic media. Their grievances (if any) may be submitted to the Dean/Principal through proper channel. They are not permitted to approach the legal authorities/ NMC/Govt. without prior permission by the Institution and University. In case of violation of the conduct rules, the admission of the candidate is liable for cancellation apart from invoking the terms and conditions of the bond.

17. RAGGING:

Ragging is prohibited in the Educational Institutions of State of Telangana and students shall not involve in ragging which may lead to serious consequences including cancellation of seat and punishments as per law.

18. All the PG Medical students for both Degree and Diploma shall submit a bond to serve the Government of Telangana for one year after completion of course as per Government Regulations at the time of admission.

19. Any candidate who has applied online and uploaded certificates for verification and exercises web options for web based counseling is deemed to have read the Prospectus and shall abide by all conditions and clauses of the Prospectus.

Note : All the dates are tentative and the University reserves the right to change them without assigning any reason or advance notice.
