1. The Contractor shall provide the Id card (as specified by the hospital Authorities) to the Staff deployed b y him/her. In absence of Id card contractual worker will not be allowed to attend the duty, Further penalty @ Rs. 100/- per day will be levied in case of failure to produce Id card.

2. The Contractor shall be liable to make the timely payment to the workers so deployed on or before 7th o f every following month from own pocket and under no circumstance their payment should be delayed or withheld i.e. on the ground of non-payment/settlement of bills by the ESIC failing which a penalty of Rs. 20 0/- per day will be imposed and deducted from the claimed bill.
